- Any combination of the following skills:
 - Industry experience Social work, community development, not-for-profit management, outreach ministry, governance, philanthropy

 - Governance Policy development, finance, human resources, strategic planning, risk management

Mosaic Life Care is committed to providing opportunities for a diverse mix of individuals, even if you are new to a Board role, and will provide professional development to all Board members. Board positions are voluntary and appointments are made for a two-year period with the option of extending the appointment for a further 2 years.
